### WHAT KINDS OF CONTRIBUTIONS QUALIFY?

**Cash** – documented with a copy of the check.

**Services** – documented by payroll records and documentation of the “normal billing rate for nonprofits.” Normal billing rates are direct hourly wages without fringe benefits.

**Stocks & Bonds** – documented by the transfer certificate and valued by the stock market price on the day of the transfer.

**Personal Property** – valued at the lesser of its fair market value or cost to the donor and may be inclusive of costs incurred in making the contribution but shall not include sales tax.

**Real Estate** – only when title thereto is fee simple absolute and is clear of encumbrances. Value is established as the lesser of two current independent appraisals conducted by state licensed appraisers.

# The Challenge Is Now

In September of 2014 Flinthills Services opened the doors of a new day program in Andover to six clients. This Andover location is now at capacity, serving over twenty clients, with more who have expressed a desire to



attend. Additionally we have brought Special Olympics and Teen / Young Adult Fun Nights under our umbrella. The growth of these programs has presented new challenges and opportunities.

We have outgrown the current day program location, and we have acquired a larger facility at 202 E. Rhondda Avenue at the end of 2021. The new location will provide more space for day services, social events, and some Special Olympics practices. The site will require renovations that include: installing flooring, updating the kitchen, pouring concrete, and building a handicap accessible shower.

In order to fund renovations, Flinthills Services has received \$118,500 from the Community Service Tax Credit Program through the Kansas Department of Commerce. This program will offer a great tax advantage for donors.

***Contributions made by business firms or individuals that pay Kansas income tax are eligible for a 70% tax credit.***

Donations must be \$250 or greater and the payment should come directly from either the business firm or the individual. **Flinthills would be authorized to offer tax credits for qualified contributions received between the eighteen-month period of July 1, 2021 to Dec. 31, 2022.**

The Community Service Tax Credit Program provides an opportunity for private non-profit organizations and public health care entities to improve their ability to undertake major capital campaigns for projects involving children and family services, non-governmental crime prevention, youth apprenticeship and youth technical training and health care. Under this program, the state authorizes specially selected non-profit organizations to offer tax credits to donors making contributions to the approved projects. The Director of the Business and Community Development Division of the Kansas Department of Commerce is responsible for the program.
